Nevada SPCA takes in over 2000 animals annually, providing them temporary shelter, medical care and then rehomes them into new, loving families.

Nevada SPCA is a safety net for our community's homeless pets, with over seventy-five percent of our animals coming from owners who need to surrender them for a variety of reasons including financial insecurity and family changes. The rest of our intake is from transfers from other local shelters to help pets that require more medical attention in order to prepare them for adoption. Nevada SPCA found homes for 1461 animals in 2020 including 902 cats, 352 dogs, 82 guinea pigs, 60 rats, 34 rabbits and 1 chinchilla. In addition to adoption, Nevada SPCA increases the human-animal bond in our community through robust volunteer and foster programs with over 26,743 foster and volunteer hours in 2020 which is the equivalent of 12 full-time employees. On November 15, 2020, through a start-up partnership with PetFlow, a local online pet food retailer, Nevada SPCA launched its Drive-Through Pet Pantry at our shelter to provide free dog and cat food to our community's families in need every Sunday.
