Nevada SPCA is a safety net for our community's homeless pets, with over sixty-five percent of our animals coming from owners who need to surrender them for a variety of reasons including financial insecurity and family changes. The rest of our intake is from transfers from other local shelters to help pets that require more medical attention in order to prepare them for adoption and orphan kittens from the streets. Nevada SPCA found homes for 2557 animals in 2022. Nevada SPCA increases the human-animal bond in our community through robust volunteer and foster programs with over 250 active volunteers and over 150 active foster parents: our foster parents fostered 781 foster pets in 2022. Nevada SPCA continued its Pet Pantry started in 2020 to provide free dog and cat food to our community's pet owners in financial need and provided 32,731 meals to those owners' pets.
